## Subject: Change in Promoter/ Promoter Group of Times Guaranty Limited ("The Company")

Dear Sir/Madam,

This has reference to our letter dated 14<sup>th</sup> December, 2023 wherein we had informed regarding execution of a Share Purchase Agreement (SPA) between Bennett, Coleman & Company Limited ("BCCL or Seller"), the Promoter of the Company and M/s Team India Managers Limited, Mr. Surajkumar Saraogi, Mrs. Sharda Omprakash Saraogi and Mr. Karan Surajkumar Saraogi ("Acquirers"), under which the Seller had proposed to sell its entire shareholding in the Company (i.e., 67,37,399 equity shares having face value Rs. 10/- each, representing 74.92% of the share capital of the Company) to the Acquirers.

Upon receipt of approval from RBI for change in control and management of the Company and conclusion of the Open Offer process to the shareholders by the Acquirers, as part of the consummation of transaction agreed under the SPA, 67,37,399 equity shares (representing 74.92% of the equity share capital) of the Company held by BCCL stood transferred to the Acquirers today i.e. 7<sup>th</sup> November, 2024. Additionally, one of the Acquirers i.e. Team India Managers Limited had also acquired 24 equity shares of the Company pursuant to the Open Offer.
